- 5. Second letter if required gives specific time to correct issue
- 6. Final demand letter comes from attorney
- 7. Mediation

ARC Committee discussion ended. Board returned to agenda.

Treasurer's Report: Board agreed to send stronger collection and lien letters (per past KCHOA letter samples Clarissa sent to Board). Interest to be added. Heather will provide interest by recipient.

Other:

- Homeowner violations
 - Irene Adames accused of renting rooms to non-family members. Violates Section 3, Article 6.
 - Mark and Tara Lampman moved without paying dues concerns about foreclosure. File lien against home.

• As response to hail damage and homeowner request, Clarissa to find an article about selecting the right roofing company and post to Facebook. Possibly post a sign about using caution when hiring a roofer.

Officer Positions:

Jared Eller resigned from the board. After discussion, Board agreed to invite Jared to return to Board (Board appoints open board position). Walt Monser moves to President, Earl Henry steps in as Vice President. Jared Eller is Director.
