review PRIOR to your project beginning. Review the covenants for a full list of projects requiring ARC approval. You can access the ARC request form on our website.

To submit your request, simply email the completed form to <u>ARC@kings-cove.org</u>. The ARC Committee will review your submission at a meeting, the date/time/location of which will be posted on the neighborhood announcement board and on our community Facebook page.
